FUNDRAISING INFORMATION

- The CMC **Political Action Committee (PAC)** was established in 2003.
- The CMC Political Action Committee maintains its own **financial and legal independence**, but is controlled by your CMC Board of Directors. The **CMC Board of Directors** is the oversight committee for CMC PAC actions and works in conjunction with CMC staff.
- The CMC Political Action Committee (PAC) is registered with the state of California (PAC ID# 1264568). In accordance with state law, CMC reports to the Secretary of State its donations and where/when PAC funds are spent.

GENERAL PAC CONTRIBUTION GUIDELINES:

- 1) Either an **individual** or **company** can contribute to the CMC PAC.
- 2) Contributions to the CMC PAC can be earmarked to **support specific candidates or initiatives**, or can be **made without specification**. Contributions made without specification are used at the discretion of the CMC Board.
- 3) The CMC PAC contribution limit for both a company and individual is **\$5,600/calendar year**.
 - a) Individuals who also own a company contributing to the CMC PAC have a **combined “company+individual”** limit of \$6,000/calendar year.
 - b) A company or individual can make a donation to the CMC PAC (limit \$6,000/calendar year) **and also make a donation directly to a specific candidate**. But if you contribute to a specific candidate and also make an earmarked contribution to the CMC PAC for that same candidate, then both amounts count towards the limit. The current limit to a specific candidate is \$3,600/calendar year.
- 4) **Contributions to a different PAC(s)** can be done as long as the company or individual does not earmark that money for a specific candidate or initiative that was already supported through a donation to the CMC PAC.
